TUESDAY, NOVEMBER 8, 2016

8:00 am to 7:00 pm at the Old Town Hall, 45 Washburn Road

Sample ballots will be available on our website or at the Municipal Building. The Town Clerk/Tax Collector's office will be closed on Tuesday, November 8th during the general election.

Requests for ABSENTEE BALLOTS

Absentee ballots are available from your town or city clerk approximately 30 days prior to an election. Request the absentee ballot application from the clerk; or, if you wish, you may submit a request in writing which should include all the information that is required on the application. Don't forget your name, home address, mailing address (If different than your home address) and your signature. An *application* for an absentee ballot may be transmitted by facsimile to a town or city clerk (Alexandria Town Clerk fax#603-744-8577). The last day to request an absentee ballot is November 7, 2016.

Return of ABSENTEE BALLOTS

Clerks may accept completed absentee ballots submitted in person by the voter until 5:00 p.m. the day before an election. A voter's absentee ballot may also be returned in person by the voter's parent, spouse, sibling or child to the town clerk before or on the day of election. The person returning the absentee ballot shall complete a form and provide proper ID before the clerk will accept the ballot. Also, absentee ballots will be accepted until 5:00 p.m. on election day if received through the mail and postmarked.

NEVER leave a completed absentee ballot in a box, on a desk, or slipped through the clerk's window or door.

A marked absentee ballot **may NOT** be transmitted by facsimile to a town or city clerk.

Money in our Pockets

September savings were \$426. This includes monies received from the redemption of scrap metal, aluminum cans and a quarterly adjustment for glass. This puts our total year to date savings for the year at \$1087. Our outlook for the remainder of 2017 continues unchanged, with the expectation of see some fluctuation from month to month depending on prices fetched for aluminum, copper, and scrap metal; we're not looking for any major changes before the end of the year. We are continuing to keep a close eye on the market for glass. As more uses for recycled glass are developed, the demand should increase, and the price paid by the vendors for glass should also increase accordingly. The recycling market is expected to remain volatile with fluctuating demand and unstable pricing. Until it works its way through the current cycle, we need to keep mindful of the important role each of us plays in protecting our environment and preserving our precious non-renewable resources. Your continued enthusiasm and support of your recycling program is greatly appreciated – recycling does have a positive impact and benefits all of us.

Everyone Does Make a Difference

As of July 18, Coca Cola of Northern New England officially stopped sending any trash at all to a landfill. Last year, the bottler's plant in Londonderry produced about eight dumpsters worth of trash, a drastic reduction from the five dumpsters per month that the facility would have been throwing away without its recycling programs. Thanks to the company's comprehensive recycling program and its commitment to preserve the environment, now, even those five dumpsters will go to a waste-to-energy plant in Haverhill, Mass. instead of to the landfill. Waste-to-energy facilities like the one in Haverhill are not without controversy, and New Hampshire has faced enduring debate about the environmental impacts of the waste-to-energy process. However, according to Michael Wimsatt, director of the NH Department of Environmental Services' Waste Management Division, critics are most often concerned about the facilities' emissions and the higher concentration of metals found in the ash that must be taken to a landfill after burning that trash. New technology being employed has resulted in a much 'cleaner' burning process, and Wimsatt says that landfills that house this ash material don't create large amounts of methane, a potent greenhouse gas, the same way a regular landfill does; and extra precautions like multiple liners are also put in place to prevent an ash-filled landfill from failing. Coca Cola's new contract with Casella Waste, combine with existing other

waste-reduction and environmentally friendly company policies long used by the bottling plant, is the final step in creating a zero-landfill facility. Other policies practiced at the plant include attempting to recycle every possible material, sharing ideas with other businesses, installing full LED lighting and altering truck routes to make them more efficient. Ray Dube, sustainability manager for CCNNE said this focus on efficiency has been part of CCNNE's company culture for 40 years.

Tip of the Month

NHDES Steps up Enforcement of Open Burning Rules

To protect public health and the environment from the illegal burning of household trash and construction and demolition debris, NHDES is stepping up enforcement efforts and will issue fines to those burning illegally, in accordance with the NHDES Compliance Assurance Response Policy. NHDES will also continue to educate the public about the open burning rules and proper disposal methods for waste materials.

Controlling sources of air pollution is not just a responsibility delegated to industrial operations; it is also the responsibility of every citizen of New Hampshire. Current law prohibits the open burning of household trash and construction and demolition debris for homeowners and industrial operations. Violations of the ban are subject to a monetary fine. This ban was established by the New Hampshire Legislature in 2001 for household trash and in 2008 for construction and demolition debris. It reflects our evolving understanding of the adverse effects of uncontrolled burning of these materials on human health and the environment.
