Money in our Pockets

Happy New Year! December savings were \$(44) including money received from the redemption of scrap metal and other metals; there was a \$343 adjustment for glass during the month. Aluminum cans were not redeemed in December. This puts our total year savings at \$1,544. Throughout the year we have battled falling prices for recyclable materials and increasing processing fees; yet we have still managed to save money. This is a tribute to our Board of Selectmen, the management and staff at the transfer station, and, above all, the participation and support of our community – without you behind the program, it couldn't happen.

Everyone Does Make a Difference

In the ongoing discussion about whether manufacturers, material recovery facilities (MRFs) or recyclers should be responsible for the sustainability of plastic packaging, the answer still seems to be "all of the above". Each segment of the process has its own challenges which it must constantly address and resolve if it is to meet the demands of our ever changing world.

This month I'm going to zero in on the Material Recovery Facilities [MRFs], discuss some of the issues they face, and how they are dealing with them. MRFs have always had to keep up with an evolving waste stream by adapting to the various shapes and sizes of consumer packaging that end up on their tipping floors. "We continue to see more and more products [packaging] in the marketplace that, in fact, are difficult, if not impossible, to recycle so they become a contaminant in the recycling stream," said Steve Alexander, executive director of the Association of Plastic Recyclers [ARPs]. APR doesn't believe that brands [those who control packaging design and manufacturing] intentionally design product packaging with inherent recycling challenges, but says it still happens far too often. By releasing an updated design guide last year, APR hopes to become more involved in the "embryonic" stage of package development rather than having to find solutions after the fact. An example of flawed package design is what has happened with full bottle or shrink sleeve labels on plastic bottles. The labels detach and sink during washing phase of the plastic recycling process and in many cases create sediment and contaminate the end material. A research company, Plastics Forming Enterprise, has been working with APR, brands, and recyclers to sort out the details of their packaging challenges in an effort to produce a cleaner material stream to ensure that recovery facilities can offer a better product and manufacturers can have higher percentages of recyclable content in their packaging. The retailers are driving the brands and the brands are driving the increase in the demand for packaging with a higher recyclable content.

Wal-Mart and Target are seen as the biggest retail drivers of this trend because both have begun requiring the use of How2Recycle labels on more of the products sold in their stores. "How2Recycle" is a standardized labeling system that clearly communicates recycling instructions to the public. A recent online survey conducted by Harris Poll indicates 44% of the adult population must rely on their own devices to figure out what can and cannot be recycled, information about the recycling process, and other details about recycling. The "How2Recycle" program is run by the Sustainable Packaging Coalition, which works with APR and others to verify the recyclability of any product seeking to use that label. This innovative

labeling system has begun to have a notable presence in the market place, but it's unlikely it will ever fully cover everything that ends up on store shelves.

The packaging community is definitely not going to stop innovating, nor should they. All of the collaboration between brands, researchers and recyclers in the future adaptation of products doesn't change the fact that a wide range of difficult to recycle plastic packaging is still ending up in MRFs right now, and will continue to for the foreseeable future. As with anything in the free market, the solution process may not always be fast or direct, and if recycling plastic packaging becomes too complicated, especially with varying standards between neighboring municipalities, it could have an adverse effect. If we confuse the consumers, they'll become disenfranchised, and before long they'll become nonparticipants in the recycling effort. The problems are real, the challenges demanding, and solutions must be found; in the meantime the cost to manage waste effectively continues to increase with no end in sight.

Reusing Makes Good C

Used Plastic Grocery Bags Can Find New Life around the Home



Keep stain and paint from drying out. Place an old plastic grocery bag over the top of an open can of paint/stain. Depress the center to forma dimple about ½" deep. Replace the lid and tap down tightly. Trim the excess plastic off with a pair of

bags into strips, which are then strung or woven together in a single long strand. You can use plarn to crochet or weave sturdy, reusable tote bags, doormats, and much more.

Wedge plastic bags under seldom used doors to prevent drafts, or where pipes pass through outer walls or from unheated to heated areas















When traveling, use plastic grocery bags to protect clothing from shoes in suitcase, to hold dirty laundry, or place your cosmetics in a bag in case of a possible leak.





If you leave your car out in the elements in the winter, try wrapping a plastic bag around the outside mirrors to prevent them

from icing. A plastic bag wrapped around outdoor padlocks keeps them free from ice and working well.

NOTICE FROM NH DEPARTMENT OF SAFETY, DVISION OF MOTOR VEHICLES

The NH Department of Safety, Division of Motor Vehicles is pleased to announce that a new computer system (VISION) will be implemented in the month of February. As a result, there will an interruption of motor vehicle registration processing statewide. Town/City Clerk's offices, along with DMV offices, will be unable to process new or renewal registrations over the President's Day holiday weekend, beginning February 17, 2017, and will be resuming transactions on Wednesday, February 22, 2017. Throughout this process, the Town/City Clerk's office may be open for other transactions not related to vehicle registrations during their normal, scheduled hours of operation. Please check with your local municipality for their specific hours during this time.

If you have a new registration, a temporary plate or your registration renewal is due during the month of February, please make sure you are aware of the processing interruption.

Please feel free to visit the DMV website at www.nh.gov/dmv for updates concerning this implementation.

The Alexandria Town Clerk/Tax Collector's office will be open normal business hours during this transition but, as mentioned above, we will be unable to process registrations from February 17, 2017 through February 21, 2017.

****Legal Question of the Month*****

Do the Police Have to read you Miranda if you get arrested?

The answer is No, no matter what you see on TV.

The Miranda Warnings are in place to advise arrested individuals of their 5th amendment rights against self incrimination. These rights are always in place, whether you are arrested or not. If the Police wish to ask a suspect questions while they are in custody we are required to specifically explain these rights to the suspect before we illicit any incriminating statements from them. That means we only have to read an arrested person Miranda if we are going to ask them questions while they are in custody.
