

Alexandria Selectmen's Meeting Minutes

August 29, 2017

- The meeting came to order at 6:00 p.m. The Pledge of Allegiance was recited.
- The minutes of the August 15, 2017 meeting were approved.
- **Items Reviewed and Signed**

- **Business**
 - The Selectmen reviewed the MS-434 Revised Estimated Revenues to be submitted to the NH Department of Revenue Administration.
 - The Selectmen addressed concerns from residents on Morrison Road regarding the plans for the new owners of 159 Morrison Road. The concerns included potential plans that may violate deed restrictions placed on properties within the subdivision; mobile home restrictions and animals for commercial use. The Selectmen explained that the Town has no zoning ordinance that would restrict the use of the property and that deed restrictions are not enforced by the Town but should somebody violate the deed restrictions, other property owners within the subdivision could file a civil complaint with the court.
 - The Selectmen reviewed a letter received from the State of NH Department of Transportation regarding public meetings being held for input on their Transportation Ten Year Plan; public input is requested and the nearest meeting for our district is being held on Thursday, October 5, 2017 at 2:00 pm in Plymouth at the Plymouth Town Hall.
 - Mr. Tuthill announced that the Special Election for State Representative for Grafton District 9 is being held on Tuesday, September 5, 2017 at the Town Hall, 45 Washburn Road and polls will be open from 8:00 am to 7:00 pm.
- **Department Head/Committees**
 - Michael Provost, Health Officer
 - Mr. Provost is still working with NHDES regarding the pile of mattresses at other items on a property on Orange Road; some work has been done to dismantle the mattresses and discard the fabric and the metal is still on site.
 - Merry Ruggirello, Planning Board
 - Ms. Ruggirello questioned whether the planning board needed to have a separate phone line in the planning board office or if messages could just be taken down by the Selectmen's Office and relayed to the planning board clerk.
