## October 13, 2015

- The meeting came to order at 6:00 p.m. The Pledge of Allegiance was recited.
- Meeting minutes from September 29, 2015 were approved.
- **Items Reviewed and Signed**
  - Land Use Change Tax: William Counter, Map 408 Lot 21-3
  - Healthtrust: COBRA Administrative Services Agreement
  - Healthtrust: Retiree Billing Administrative Services Agreement
- **Appointments/Department Heads**
  - Alexandria Recreation Advisory Council
    - Sue Cheney was present to provide an update on the services provided by the Alexandria Recreation Advisory Council and the expansion of program offerings at the Alexandria Village School.
  - Jeff Cantara, Road Agent
    - Mr. Cantara provided an update on highway department projects in progress, including fall grading, vehicle preparation for winter, gates on Bog Road and Cole Hill Road bridge work.
    - There was discussion regarding David Blais working part-time for the highway department for the winter.
- **Business**
  - After discussion, the Selectmen made the decision to reclassify Deborah Bones property to a one family residential instead of a two family residential.
  - The Selectmen requested that copies of the Master Plan survey results be obtained from the Planning Board.
