
## NH STATE PRIMARY VOTING

## Tuesday, September 8, 2020

The New Hampshire State Primary will be held at Alexandria Town Hall, 45 Washburn Road, Alexandria, NH. The polls will be open from 8:00 am to 7:00 pm.

The Town Clerk/Tax Collector's office will be closed on Tuesday, September 8, 2020 for the State Primary Elections and will only be open from 3 pm to 5 pm on Monday, September 7, 2020 (Labor Day) for absentee ballot requests.

### Money in our Pockets

We continue to save money by recycling. In July we had revenue of \$253 from aluminum cans and \$470 from tin and light metals. We also had a quarterly adjustment for glass of \$345. That bring our year-todate savings to \$3,486. We are still behind last year at this time but can still net a year end savings of over \$5,000 if we all continue our recycling efforts. There is still no sign of sustained improvement in the marketplace, but there are indications that the market for baled corrugated cardboard is beginning to open slightly. Remember that in addition to saving us money, your efforts to recycle have a positive impact on our environment and preserve our natural resources.

## What's New at the Transfer Station

The Siting Committee met on August 4th and August 18th. The meeting on the 4th was with architectural engineer Erin Darrow during which we discussed the topography of the newly acquired property and potential site locations for the transfer station facilities and gravel excavation. At our meeting on the 18th Paige Wilson from the Lakes Region Planning Commission talked with us about grant money opportunities and imparted insight into what some other New Hampshire towns had done. The committee also reviewed a trip summary to the Gilford transfer station facilities. A survey questionnaire seeking input from the residents was approved and is available at the transfer station, Municipal Bldg., and on-line. Please take the time to complete this survey as your input will help guide us in the development of the new facility.

We are making good progress; however, there is a lot of preliminary groundwork that needs to be completed. Copies of the minutes may be viewed on the town's website under the Commission/Committee topic heading [all minutes are subject to approval by committee members at the



next scheduled TSSC meeting and are subject to change until that time]. You are encouraged to attend meeting and reference the minutes for more detailed information. This section of the newsletter is not intended to replace the minutes, but rather to give residents a status overview as we move forward.

### KEEP YOUR EYES PEELED FOR THE SURVEY QUESTIONAIRE – IT'S YOUR CHANCE TO LET US KNOW WHAT YOU WANT AT THE NEW TRANSFER STATION FACILITY. QUESTIONAIRES ARE AVAILABLE AT THE TRANSFER STATION, THE MUNICIPAL BUILDING, AND AS AN ON-LINE SURVEY. PLEASE TAKE THE TIME TO PARTICIPATE!

I don't want to keep harping on the same issues every month as our position is that only an occasional reminder should be necessary. The majority of our residents are cooperative and try to follow the rules – those who choose not to, will continue to cost the town money and 'reminders' won't help.

In the last month, there has been an abnormal number of large loads finding their way into the compactor. This will happen on occasions for a variety of reasons; however, the compactor is hauled on a scheduled basis and abnormally large loads can disrupt that schedule. You can help us out by planning your trips to the transfer station on a regular basis, don't accumulate trash until you "must make a dump run." Remember only household trash goes into the compactor. Construction demo materials of any type go into the 'Construction Demo' container. If for some reason, you have an oversize load of household trash, please speak with a staff member before putting it in the compactor. Thank you for your cooperation.

On June 1st of this year, our cost for the disposal of tires increased and as a result we are having to increase the fee we charge accordingly. Regular car tires are now \$3.00 ea. w/o rims and \$4.00 ea. with rims; other size tires are charged according to size and # of ply. Please note the size and see the attendant before disposing of any tires. We regret that an increase is necessary, and rest assured that this increase only reflects the additional cost to us – all fees charged at the transfer station are reflective of our cost for disposal, no profit is built into any of the fees we charge.

We continue to do our best to keep the recycling process as simple as possible for our residents, but things change, and we have no alternative but to go along with the changes. Please understand that the staff at the transfer station are not trying to give you a hard time when they stop you from putting something that doesn't belong in a recycling bin or question you about not displaying a sticker, it's their job and they are merely trying to save the town money.

## **Every Individual Can Contribute**

Plastic is not a bad material. In fact, the invention of plastic has had enormous impacts on several industries, making products and services more accessible than ever before. The problem lies in how we dispose of it. Only 14% of end-use plastics are recovered, leaving the rest to accumulate in landfills, enter waterways, or become incinerated.

In recent years there have been significant strides made in recycling plastic for use in other product manufacturing; however, recycled plastic is not generally used to create new plastic products. Over time, repeated use and recycling of plastics break down its molecular structure components. As a result, recycled plastics tend to degrade in quality over time, eventually becoming unusable.

Researchers from Chalmers University of Technology in Sweden may have found a way to surmount this limitation. Published in *Sustainable Materials and Technologies*, the research group was able to recover 100% of carbon from plastic waste and turn it back into its virgin components. They introduced steam and heat to break down the organic molecules into their hydrocarbon components, which is what most plastics are made of, to form a gas mixture. Now in the form of a gas mixture, the carbon can then be



recovered to create the components of virgin plastic. They found that switching to converted plastic waste as feedstock [raw material], instead of virgin plastic, for creating new plastics provides economic advantages and is technically feasible. This would help give used plastics a true value, and thus an economic impetus for collecting it anywhere on earth.

The Chalmers researchers are now looking to scale the process even further. With the success of their further research, there's a good possibility that this could see commercial use in the future. #### Alexandria Conservation Commission

Come September, the raptors; birds of prey like hawks, eagles, and falcons, start to migrate. Thanks to NH Audubon's migration watch program, you can have the amazing experience of seeing them up close as they make their way to their winter habitats. Each fall, beginning on September 1st, New Hampshire Audubon biologists and volunteers track the migration of raptors at two well-known raptor migration hotspots: The Pack Monadnock Raptor Observatory, located within Miller State Park near the summit of Pack Monadnock Mountain in Peterborough, and Carter Hill Orchard in Concord where you can combine apple picking with watching the hawk migration. Data from both locations is shared with the Hawk Migration Association of North America and becomes part of a long-term international database. Thanks to the international database (hawkcount.org), scientists can assess and analyze trends across a broad scale. In the Northeast, it has been determined that the populations of



many raptor species are stable or even increasing. For example, Bald and Golden Eagles have both recovered well and populations are on the increase, whereas American Kestrels and Northern Harriers falcons are declining.

The public is welcome at both locations. There is a fee to get into Miller State Park; however, the observatory is free. Migration activity is most pronounced on northwest winds, especially on the several days following the passage of a cold front. Raptors are majestic birds and watching a wide variety of hundreds together is a fun experience for both the avid raptor enthusiast and the entire family.
