- Make the entrance very large & plenty of pull up room for demo & compactor containers


- Very excellent staff tony- carl very helpful very clear nice guys

- On how they feel about accepting materials from other towns: not enough information to judge pros/cons




How often do you visit the Alexandria Transfer station?





Please indicate which services, provided by the transfer station, are most important to you by ranking them 1-9.




