Mrs. Dostie suggested establishing a capita improvement committee to discuss long-term planning for all departments within in the Town. After discussion, Mr. Tuthill suggested that a meeting with department heads be scheduled to begin the process of establishing a capital improvement planning committee.
- Mr. Sirard announced that the road closed signs have been removed.
- Mr. Tuthill stated that there are infrastructure grant funds available for certain types of highway improvement projects; he is checking to see if Alexandria has any upcoming projects that qualify.
