## ❖ Departments/Committees

- > Chief David Suckling, Police Department
  - Chief Suckling informed the Selectmen that he will not be working in Danbury after the end of June. There was a discussion about whether Chief Suckling felt that it would be worth pursuing combining the departments. Chief Suckling expressed that he thought having an agreement drafted would have improved the voting results in Danbury.
  - Chief Suckling provided information to the Selectmen about body worn cameras. Alexandria is on a waiting list for a fifty percent grant funding through the state.
  - Chief Suckling provided information to the Selectmen about FirstNet cell phones through AT&T. The
    police department has been using demo phones from the company and the service area covered in
    town was better than what we currently use. The FirstNet service network is designed for public
    safety.
  - Chief Suckling informed the Selectmen that he offered to keep Danbury's gun in the Alexandria evidence room for safety; the Selectmen approved this decision.
  - There was a brief discussion regarding the state approving the carrying of loaded weapons on ATV's and snowmobiles.
  - Chief Suckling thanked the Selectmen for attending the award ceremony where he was presented a Champion for Children award by the N.H. School Administrators Association.

## Business

• Mr. Tuthill announced that the next district meeting to review the school funding formula is scheduled for July 13, 2022 at 6:00 pm in the library at the Newfound Memorial Middle School. The committee will be following up on information provided about expenses that are sensitive to student enrollment numbers and expenses that are not sensitive to student enrollment numbers.
