- Announcement: Town Voting Day, Tuesday, March 11, 2025 at Town Hall, 45 Washburn Road. Polls are open from 11 am to 7 pm. The Alexandria Park and Recreation group will be having a bake sale at town hall on voting day.
- > AMC/Shem Valley Road
 - The Selectmen expressed concern regarding public safety and road maintenance equipment space concerns on Shem Valley Road up to the AMC lodge. The land on either side of Shem Valley Road in that area is owned by AMC and the State. Concerns were expressed that there is not adequate parking at the lodge for people visiting the area and it results in parking along the side of the road and not adequate space to turn around town equipment when working on the road. The Selectmen had sent a letter to our state Senator and Representatives with their concerns; Senator Innis responded that he will contact AMC with the concerns. Paul Sirard said that he had previously met with representatives from AMC and the state regarding parking and, while they agree it is a concern, there was disagreement on who would pay for creating parking space and the location.

 resolution. The Selectmen voted all aye to the resolution.
