March 18, 2025

- ❖ **Business**
 - The Selectmen thanked people that volunteered on voting day and that came out to vote.
 - Donation
 - The Selectmen accepted a donation of \$5,707.19 from the CARE Group for the Conservation Commission.
 - Lakes Region Planning Commission
 - George Tuthill's term as alternative representative for Alexandria to LRPC expires May 2, 2025; Mr. Tuthill expressed that he is willing to serve as representative for Alexandria to LRPC for another term.
 - Transfer Station
 - Work at the new Transfer Station site has started up again.
 - Street Lighting
 - Cam Oulette was present to ask about the status of moving forward with the street lighting project. The Town has already paid for the fixtures and they will need to be installed by Eversource. The Selectmen explained that the for the installation was more than anticipated and is not in the budget for 2025.
 - Brian Lewis commented that NHEC is running their new broadband cables in Town. The Selectmen explained that NHEC is running the fiber in areas where they have existing customers and that they are working with NHEC to run additional fiber in areas that are served by Eversource.
 - Nancy Whitman suggested that the Town come up with a way to educate townspeople more about the warrant articles items prior to voting day. Brian Lewis expressed that almost everything on the warrant passed and that people must have faith in local officials and budget committee members for that to occur.
