### Town Clerk/Tax Collector's Office

**WELLINGTON STATE PARK PASSES:** Wellington State Park beach passes will be available to be purchased through the Town Clerk/Tax Collector's Office at the beginning of June. Wellington State Park is owned and run by the State of New Hampshire. Each year, the Town applies for a special use permit from the State in order to provide the passes. The special permit only grants the town the ability to sell passes to residents and/or taxpayers of the Town of Alexandria, their spouses and dependent children. The beach passes are nontransferable. Please keep in mind that the state recommends making reservations to the park; otherwise access to the park is on a first come/first serve basis. #### 2025 Wellington State Park Beach Passes

Passes are in the Town Clerk's office  
and are available only to Alexandria residents and taxpayers.

Adults ages 12+:	\$6.00
Children age 6 to 11:	Passes are required for each child but at no charge
Children age 0 to 5:	Free, no passes needed
NH Residents over 65:	Free with a NH driver's license or ID — no pass required

To purchase by mail, please send a self-addressed, stamped envelope with a list of names and ages with a check for the correct amount made payable to Town of Alexandria.

**Service Fee:** We are using Invoice Cloud to process your actual payment. To cover the cost of the transaction, Invoice Cloud charges a service fee, the amount of which depends on the method by which you choose to pay and the costs to Invoice Cloud associated with processing that type of transaction. Electronic checks (ACH) are charged a flat fee of \$0.95 per transaction. Credit and debit cards are charged 2.95% of the amount being paid. For instance, if you are paying \$100 by credit card, the service fee will be \$2.95. **Making a Partial Payment?** Partial payments can be made by adjusting the Payment Amount on the Check Out Page.

### Selectmen's Office

#### Low & Moderate Income Homeowners Property Tax Relief Program:

Applications for the Low & Moderate Income Homeowners Property Tax Relief Form (DP-8) should be **available after May 1, 2025**. The Low & Moderate Income Homeowners Property Tax Relief program was designed to lessen the economic burden of the State Education Property Tax on certain at-risk taxpayers.

An eligible applicant for the Low and Moderate Income Homeowners Property Tax Relief is a person who is:

- Single with adjusted gross income equal to or less than \$37,000; or
- Married or head of NH household with adjusted gross income less than or equal to \$47,000; and
- Owns a homestead subject to the State Education Property Tax; and
- Has resided in that homestead on April 1 of the year for which the claim is made.

Applications for the Low and Moderate Income Homeowners Property Tax Relief are accepted only during the statutory filing period - after May 1, but no later than June 30. The law allows 120 days for processing from the date of receipt of your completed application. 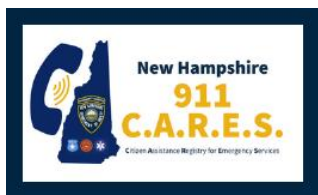

**What is 911 C.A.R.E.S.?** New Hampshire 911 C.A.R.E.S. (Citizens' Assistance Registry for Emergency Services) is a program of the Division of Emergency Services and Communications that allows account holders to associate a phone number with an individual who has a chronic medical condition or additional information that is vital for first responders. When NH 911 is called from a phone number registered with C.A.R.E.S., the NH 911 telecommunicator answering the call has immediate access to the information that has been submitted to the C.A.R.E.S. database.

A C.A.R.E.S. entry can provide additional contextual information for a telecommunicator as they handle a call. Examples of conditions that are eligible for C.A.R.E.S. entries include conditions that may affect the caller's state of mind, may affect the initial actions of first responders arriving on scene, or may affect the caller's ability to communicate. Eligible conditions include Alzheimer's, dementia, cognitive disability, epilepsy, diabetes, hearing impairment, the presence of a pacemaker or LVAD, medication allergies, and more. A C.A.R.E.S. entry may also include information to help first responders access a patient, such as gate codes for security gates or a note regarding the presence of a service animal. All 911 C.A.R.E.S. data is stored in secure database that can only be accessed by authorized personnel. Additionally, this information will only appear on a 911 telecommunicator's screen when a call is placed from a telephone number that is associated with a C.A.R.E.S. individual.

**How do I access 911 C.A.R.E.S.?** The NH 911 C.A.R.E.S. database is a self-service program that can be accessed online by going to [cares.desc.nh.gov](http://cares.desc.nh.gov). If you do not have access to a computer/internet, paper forms can be requested through the NH 911 C.A.R.E.S. office at 603-271-6911 or email: [NH911CARES@desc.nh.gov](mailto:NH911CARES@desc.nh.gov).

### *Policy for Construction on Class VI Roads, Private Roads, and Rights of Way*

For the safety of the Town and residents who wish to reside on Class VI Roads, Private Roads, and Rights of Way, the Select Board as determined that, prior to the issuance of a driveway permit or the construction of any building, the Road agent and Fire Chief must both agree to a standard of year-round safe access, and sign the form created for that purpose.

Also, the *Notice, Agreement, and Release of Municipal Liability and Responsibility* form must be signed by all owners of record and the form is to be recorded at the Grafton County Registry. The road or right of way must be brought to the standard as determined by the Road Agent and Fire Chief prior to the signing on the release form as this form states that the road will be "maintained" by the owners of the property abutting the road or right of way.

### *Request to Perform Maintenance on Class VI Road*

Per NH RSA 236:9, "It shall be unlawful to excavate or disturb the shoulders, ditches, embankments or the surface improved for travel of any class I or class III highway or state-maintained portion of any class II highway for any purpose whatever without written permission from the commissioner of transportation or his district engineer, or any other highway without written permission from the selectmen or highway agent of the town..."

In order to make the process of obtaining permission to perform maintenance uniform and to track the maintenance on Class VI Roads, the Town will require the form "Request to Perform Maintenance on Class VI Roads" be completed and approved by the Road Agent and Select Board.

The Town of Alexandria is accepting applications for the position of **Highway Department Laborer**. This position performs work involving operating plow trucks, dump trucks, loaders, backhoes, and other moderately complex equipment for the construction, repairing, cleaning and maintenance of Town roads. Also responsible for manual labor tasks incidental to the operation of assigned equipment, such as loading and unloading materials. This position involves plowing snow in the winter and overtime is a requirement. Valid New Hampshire Class (B) Commercial Driver's License required or ability to obtain class B CDL within 6 months of date of hire. This is a full-time, year round position. The Town of Alexandria offers health insurance, dental insurance and more. Must pass all background checks including criminal and motor vehicle and drug and alcohol testing. ### Frequently Asked Questions about Burning

*Do I need a permit to burn?*

YES-Every person, firm or corporation who kindles or causes to be kindled any fire or burns or causes to be burned any material, except when the ground is covered with snow, SHALL obtain a written fire permit from the Forest Fire Warden in the town or city where the fire will be kindled. Your online fire permit meets this requirement. A gas grill or charcoal fire in a container up and off the ground kindled

by the landowner or with the landowner's permission does not require a written fire permit.

*What materials can be burned with a fire permit?*

Only burning of untreated wood, untreated pallets, campfire wood, brush, or charcoal is allowed. Wood can be no greater than 5 inches in diameter.

*What materials may NOT be burned with a fire permit?*

NO treated wood, composite material or domestic waste may be burned – including but not limited to: household trash, packaging materials, plastics, coated or laminated papers, rubber, painted or treated wood, coated or treated cardboard, oily rags, and animal, vegetable and kitchen waste. (See NH RSA 125N)

*What are the categories of burn permits?*

Category I Fire: A small, controlled fire, such as a camp or cooking fire, no greater than 2 feet in diameter contained within a ring of fire resistive material or in a portable fireplace. A category I fire, conditions permitting, may be kindled with a permit at any time of day whether raining or not.

Category II Fire: A controlled fire, such as a camp or cooking fire, no greater than 4 feet in diameter contained within a ring of fire resistive material or in a portable fireplace. A category II fire, conditions permitting, may only be kindled between the hours of 5 pm and 9 am unless it is actually raining.

Category III Fire: Any other fire, not a category I or II fire or a fire greater than 4 feet in diameter or a fire not contained within a ring of resistive material. A category III fire, conditions permitting, may only be kindled with a permit between the hours of 5 pm and 9 am unless it is actually raining, and can be used for up to 7 days.

*How close to a structure can I kindle my fire?*

A category I fire must be at least 25 feet from structures and category II or greater fire must be at least 50 feet from structures.

*If I started my category II or III fire while it was raining and it stops raining, do I have to extinguish the fire?*

Yes! The fire must be extinguished and you will need to wait until after 5 pm to kindle it again.

## Waste Management Committee

### Foam Recycling



Foam, otherwise known as expanded polystyrene (EPS) or Styrofoam, is a hard to recycle material that most Towns do not accept. You can identify it by looking for a #6 recycling symbol somewhere on the item. The Town of Gilford is the first NH hub location for foam collection and recycling. All acceptable types of foam will be densified down into plastic ingots by chopping, heating, and removing the air in a densifier unit patented by Foam Cycle, LLC. The Town of Gilford will then market and sell the ingots for reuse into new materials, thereby reducing the polystyrene going into the waste stream, our waters and our landscapes.

The general public are able to access a collection bin available 24/7 at the Gilford Department of Public Works for drop off of acceptable foam (#6 polystyrene) materials. The public is NOT currently able to access the Gilford Solid Waste Center without a town sticker or vehicle pass. Temporary day passes will only be issued to someone who has a very large amount of foam that cannot fit in the collection bin.
