- ❖ Members Present: George Tuthill, Robert Piehler and Chet Caron
- The Pledge of Allegiance was recited.
- The minutes from July 15, 2025 were approved.

## ❖ Items Reviewed and Signed

- > Letter authorizing maintenance on Perkins Hill Road
- Letter to AMC regarding parking at end of and along Shem Valley Road
- ➤ Building Notification: Map 413 Lot 70 on Burns Hill Road
- > Building Notification: Map 414 Lot 6 on Mathews Road

## Old Business

- > Tiny Homes on Town Pound Road
  - The Select Board discussed that the two tiny homes on the property appear to still violate the town's subdivision regulations and waiting for further verification.
- AMC/State of NH/Shem Valley Road parking
  - The Select Board sent a letter acknowledging the response received from AMC regarding parking/road concerns.
- Washburn Road driveway culvert
  - Highway Department has not had a chance to inspect the culvert with the camera and will be scheduling a company to clean out the culvert if it is blocked.
- > 367 Welton Falls Road
  - Michael Provost, Health Officer, said that he has found no contaminants on the property so NHDES will not get involved with an inspection. Mr. Provost stated that the property owner has a portable holding tank for septic that the property owner said there are two locations that he brings the waste for disposal. James Jackson, a neighbor to the property, suggested that Mr. Provost request receipts to prove that the waste is being disposed of properly.
  - There was discussion regarding concerns with dogs on the property; the police department is handling those concerns.
- Morrison Road
  - The owner of the mobile home that is in the cul-de-sac at the end of Morrison Road stated that he has a company scheduled to come move the mobile home to his property on Thursday, August 7<sup>th</sup>.
- New Transfer Station
  - Paul Sirard, Road Agent, said that he is obtaining quotes for paving a portion of the new transfer station site.
- Old Fire Truck
  - The Select Board discussed putting the old fire truck up for auction. Mr. Sirard suggested also auctioning the old cruise and the 2007 F550.

## ❖ New Business

- Michael Provost said that he went to a fire suppression training for his recertification as a Solid Waste Operator and that there will be a need for an emergency plan for the new transfer. He also mentioned that there is a new law that prevents the disposal of lithium batteries at transfer stations.
